Applications in prescribed form are invited from the citizen of India for the filling up the following post:

1. **Assistant Professor in English (Ad-hoc basis)** to be appointed at the Guwahati Campus, MSSV.

Pay: Consolidated Rs 15,000.00 p.m. **Qualifications** as per the UGC norms.

Last date of receiving applications: 10th February, 2020. **Application Fee:** Rs. 500.00 (Rupees five hundred) only.

DETAILED INFORMATION

I. Eligibility to apply for the posts:

1. The Applicant must be a citizen of India.
2. He/she must be medically fit both in mind and in body-a certificate duly signed by the District Medical Officer, Nagaon District or any competent Registered Medical Officer, approved by the Vice-Chancellor, shall have to be produced by any person who would be appointed as a Teacher, before/she is allowed to join.
3. A certificate about good character from the Head of the Institution last attended or served shall accompany an application for any post of a Teacher.
4. The candidate must possess the minimum qualifications for the post.

II. General Qualification, Experience and Requirements:

- (i) Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in the relevant subject from an Indian University.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET or Ph.D. Degree (under the new regulation of UGC).
- (iii) Candidates with NET and Ph.D. shall be given preference.

APPLICATION PROCEDURE

1. **Application form:** Prescribe application form may be downloaded from the University website i.e., www.mssv.co.in.
2. **Application Fees and Last Date:** Candidate are required to pay an amount of **Rs. 500.00 (Rupees five hundred) only for the post** by demand draft in favour of "REGISTRAR, MAHAPURUSHA SRIMANTA SANKARADEVA VISWAVIDYALAYA" payable at "State Bank of India, Nagaon Main Branch (IFSC: SBIN0000146)" or **Cash at Accounts Branch of the University** as an application fees for the post.

Completed application in prescribed form along with necessary enclosures must reach **“REGISTRAR, MAHAPURUSHA SRIMANTA SANKARADEVA VISWAVIDYALAYA, H.B. PATH, KOLONGPAR, NAGAON – 782001”** on latest by **10th February, 2020.**

N.B.:

- i. The name of post and department must be written on the envelop of the application.
- ii. Those in employment should submit their applications through proper channel up are submit the NOC from the authority concern.
- iii. Near fulfilment of qualification will not entitled an applicant for inviting to the interview.
- iv. The University reserves the right to select candidates for appointment to the above mentioned posts on the basis of its immediate requirements.
- v. Canvassing directly or indirectly shall disqualify a candidate.
- vi. No TA/DA will be provided by the University for attending the interview.

3. Conditions to be fulfilled after appointment:


- a) A person appointed to the post of a Teacher join **within 10 days from the date of issue of appointment order**, failing which the appointment order is liable to be cancelled, provided that in exceptional circumstances, the Vice-Chancellor may extend this period.
- b) Before a person appointed to the post of a Teacher joins in his/her post, he/she shall execute an agreement with the university that he/she shall strictly abide by the provisions of the Acts and the Ordinances. A Teacher shall also undertake in the agreement to submit to the Vice-Chancellor a self-appraisal report of his/her performance annually.
- c) The person, after joining the post of Teacher, will be subjected to the provisions of the MSSV Teachers' Service Conditions Ordinance.
