The University is looking for **meritorious, energetic and dedicated persons** to be appointed in some temporary posts of teachers (to teach at UG and PG levels) at its **Nagaon and Rupnagar, Guwahati Campuses**. Applications with all relevant testimonials from such intending candidates having UGC norms are invited so as to reach the undersigned **on or before 11th June, 2018**.

Posts of Teacher:

I. NAGAON CAMPUS:

- (A) **Professor** : (i) Economics, (ii) Education, (iii) Philosophy and (iv) Sociology;
(B) **Associate Professor** : (i) Assamese, (ii) Economics, (iii) Philosophy and (iv) Sociology;
(C) **Assistant Professor (Regular basis)** : (i) Economics, (ii) English and (iii) Philosophy;
(D) **Assistant Professor (Ad-hoc basis)** : (i) Assamese, (ii) Economics, (iii) English, (iv) Education, (v) Philosophy and (vi) Sociology.

II. RUPNAGAR, GUWAHATI CAMPUS:

- (A) **Professor** : (i) Performing Arts, (ii) Social Work and (iii) Yogic Science & Naturopathy;
(B) **Associate Professor**: (i) English, (ii) Performing Arts, (iii) Social Work and Yogic Science & Naturopathy;
(C) **Assistant Professor (Regular basis)** : (i) Performing Arts (Dance, Music and Drama) and (ii) Yogic Science & Naturopathy;

- ❖ The University shall reserve rights to transfer from one campus to the other, if necessary.
❖ Reservation of posts as per the Govt. of Assam rules/norms.

DETAILED INFORMATION

I. Eligibility to apply for the posts:

1. The Applicant must be a citizen of India.
2. He/she must be medically fit both in mind and in body-a certificate duly signed by the District Medical Officer, Nagaon District or any competent Registered Medical Officer, approved by the Vice-Chancellor, shall have to be produced by any person who would be appointed as a Teacher, before/she is allowed to join.
3. A certificate about good character from the Head of the Institution last attended should be enclosed.
4. The candidate must possess the minimum qualifications for the post.
5. Upper age limit of the candidates, if otherwise not mentioned, shall be as per the Govt. of Assam rules / norms.

II. General Qualification, Experience and Requirements:

1. Assistant Professor: Minimum qualification and experience:

- (i) Good academic record with at least 55% marks (or an equivalent grade wherever grading system is followed) at the Master's Degree level in the relevant subject from an Indian University.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET or

Ph.D. Degree (under the New Regulations). Candidates having both NET and Ph.D. shall be preferred.

(iii) In case of Performing Arts the candidates shall have Master's Degree in Performing Arts with specialisation in Dance/Music/Drama (Theatre Art).

(iv) In case of Assistant Professor (Ad-hoc basis) the requirement of NET shall be relaxed: However, NET qualified candidates shall be given preference.

Salary: Assistant Professor (Regular basis) : Rs. 30,000/- p.m. (consolidated).

Assistant Professor (Ad-hoc basis) : Rs. 15,000/- p.m. (consolidated).

2. **Associate Professor: Minimum Qualification and Experience:**

(i) Good academic record with a Ph. D. Degree in the concerned/allied/relevant discipline.

(ii) A Master's Degree with at least 55% marks (or an equivalent grade wherever grading system is followed).

(iii) **A minimum of eight years of experience of teaching and/or research** in an academic/research position equivalent to that of Assistant Professor in a University/College excluding the period of Ph.D. research with evidence of published work and a **minimum of 5 publications as books and/or research papers** in the subject concerned.

(iv) Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process with evidence of having guided doctoral candidates and research students.

(v) **A minimum API score of 300 points** as stipulated in the Academic Performance Indicator (API) as per the Performance Based Appraisal System (PBAS), set out in the UGC's revised Regulation of minimum qualifications for appointment of teachers.

Salary: Rs. 45,000/- p.m. (consolidated)

3. **Professor: Minimum Qualification and Experience:**

(a) (i) An eminent scholar with Ph.D. in the concerned/allied/relevant discipline and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 publications as books and/or research/policy papers.

(ii) A minimum of ten years of teaching experience in university and/or experience in research at the University/National level institutions, including experience of guiding candidates for research at doctoral level.

(iii) Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process.

(iv) A minimum API score of 400 points as stipulated in the Academic Performance Indicator (API) as per the Performance Based Appraisal System (PBAS), set out in the UGC's revised Regulation of minimum qualifications for appointment of teachers.

OR

(b) An outstanding professional with established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned/allied/relevant discipline, to be substantiated by credentials.

(c) **Upper Age Limit in case of the posts of Professor : A person upto the age of 63 years** with the above qualifications may apply for the posts of Professor.

Salary: for pensioners : Rs. 40,000/- p.m. (consolidated)

APPLICATION PROCEDURE

1. **Application form:** Prescribed application form may be downloaded from the University website i.e., www.mssv.co.in.

2. **Application Fees and Last Date:** Candidate will be required to pay an amount of **Rs. 2,000.00 (Rupees two thousand) only** by demand draft in favour of “**REGISTRAR, MAHAPURUSHA SRIMANTA SANKARADEVA VISWAVIDYALAYA**” payable at “**State Bank of India, Nagaon Main Branch (Branch Code - 000146)**” or **Cash at Accounts Branch of the University** as an application fees for the post. Completed application in prescribed form along with necessary enclosures must reach “**REGISTRAR, MAHAPURUSHA SRIMANTA Sankaradeva Viswavidyalaya, H.B. Path, Kolongpar, Nagaon – 782001**” on latest by **11th JUNE, 2018**.

N.B.:

- i. Those who are willing to apply more than one post they must submit separate form with separate application fees.
- ii. The name of post and department must be written on the envelop of the application.
- iii. Those in employment should submit their applications through proper channel or submit NOC from the authority concerned.
- iv. The applications may be shortlisted and only the candidates found suitable may be called for interview.
- v. The University reserves the right to select candidates for appointment on the basis of its immediate requirements.
- vi. Canvassing directly or indirectly shall disqualify a candidate.
- vii. No TA/DA will be provided by the University for attending the interview.

3. Conditions to be fulfilled after appointment:

- a) A person appointed to the post of a teacher may have to join **within 15 days from the date of issue of appointment order**.
- b) Before a person appointed to the post of a teacher joins in his/her post, he/she shall execute an agreement with the university that he/she shall strictly abide by the provisions of the Acts and the Ordinances of the University. A Teacher shall also undertake in the agreement to submit to the Vice-Chancellor a self-appraisal report of his/her performance annually.
- c) The person, after joining the post of Teacher, will be subjected to the provisions of the MSSV Teachers' Service Conditions Ordinance.
