Interested candidates having UGC norms may appear in a walk-in-interview for a post of Assistant Professor in Sociology (Ad-hoc), MSSV alongwith all original testimonials on **31st July, 2017 at 11.00 A.M.** at MSSV, Nagaon Campus.

### DETAILED INFORMATIONS

#### I. Eligibility to apply for the post:

1. The Applicant must be a citizen of India.
2. He/she must be medically fit both in mind and in body-a certificate duly signed by the District Medical Officer, Nagaon District or any competent Registered Medical Officer, approved by the Vice-Chancellor, MSSV, Nagaon shall have to be produced by any person who would be appointed as a Teacher, before/she is allowed to join.
3. A certificate about good character from the Head of the Institution last attended or served shall accompany an application for any post of a Teacher.
4. Age limit of the candidates for the post Assistant Professor shall be as per the UGC.

#### II. General Qualification, Experience and Requirements:

##### 1. Assistant Professor: Minimum qualification and experience:

- (i) Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree in Sociology from an Indian University.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.

#### III. The Candidates have to submit filled in standard form of application along with self-attested copies of all testimonials and a bank draft of Rs. 1000/- (Rupees one thousand) payable to MAHAPURUSHA SRIMANTA SANKARADEVA VISWAVIDYALAYA, NAGAON at SBI MAIN BRANCH, NAGAON.

#### IV. Conditions to be fulfilled after appointment:

1. The appointment is purely temporary and on consolidated salary.
2. A person appointed to the post of Assistant Professor shall join **within one week from the date of issue of appointment order**, failing which the appointment order is liable to be cancelled, provided that in exceptional circumstances, the Vice-Chancellor may extend this period.
3. Before a person appointed to the post of Assistant Professor joins in his/her post, he/she shall execute an agreement with the university that he/she shall strictly abide by the provisions of the Acts and the Ordinances of the University.
4. The person, after joining the post of Assistant Professor, will be subjected to the provisions of the MSSV Teachers' Service Conditions Ordinance.
