[I, _____ do hereby state the following and undertake to comply with the conditions given hereunder:

1. I have collected the MSSV Convocation Robe from the authorized person of MSSV on 23/02/2018. The Robe costume consists of a Robe and a Gamocha with a MSSV logo printed on it.
2. Under any condition I shall return the Robe as soon as the Convocation is over on 24th February, 2016 and not later than that. If I fail to do so then I shall pay a fine of **Rs. 200/- per day**.
3. No damage shall be caused to the Robe costume and shall be well maintained as long as it is under my possession. If any minor damage is caused to the Robe costume then I shall pay a fine upto **Rs 2,000/- (Rupees Two Thousand)**
